## Eligibility of Candidates

Secondary school students OR young people aged 12 to 18

## Programme Schedule

Application Deadline: Wednesday, 6 March 2024
Initial Selection: Saturday, 23 March, 2024
Selection Interview: Saturday, 4 May, 2024
Award Presentation: Saturday, 6 July, 2024

#### **Details of Nomination**

- 1. The nomination form must be signed by the nominator and candidate, and endorsed by the Principal (for nomination from school) or Person-in-charge (for nomination from NGO). Parent or guardian shall countersign if the candidate is below the age of 18. By signing the nomination form:
  - (i) The candidate accepts the nomination and certifies that the information is true, and consents to provide and disclose of such information. He/she should participate in designated activities under this Award;
  - (ii) Parent or guardian of the candidate accepts the nomination and consent to disclose related information. He/she agrees the candidate to participate in designated activities under this Award; and
  - (iii) The nominator and Principal or Person-in-charge certify the information on the nomination form to be true and correct.

### Eligibility of Nominator

- The nominator must be a school or NGO officer in Hong Kong. Individual or self-nomination are not accepted.
- The nominator can nominate more than one candidate.

#### **Selection Process**

- 1. Upon receiving the nomination form, the nominator will be notified by the Secretariat within 5 working days by email.
- 2. The Hong Kong Federation of Youth Groups will conduct preliminary screening of all nomination forms.
- 3. Selected candidates will be invited by WhatsApp on or before Saturday, 16 March, 2024 to attend an Initial Selection on Saturday, 23 March, 2024.
- 4. 30 shortlisted candidates will then be invited to attend an Interview Session with the Selection Panel on **Saturday**, 4 May, 2024. Selection panel will select 20 winners. The result will be announced in May 2024.
- 5. All winners <u>must</u> attend the Award Presentation Ceremony on Saturday, 6 July, 2024, all rehearsals, and consent to join activities of CLP Mentorship Scheme. Should candidates fail to commit to the above terms, they will be considered as having forfeited their right of continued participation.

#### Selection Criteria

- 1. Extraordinary efforts demonstrated by the candidate to overcome challenging life issues.
- 2. Impact of the scholarship to the candidate.
- 3. Comments made by the nominator.

#### Prizes

- 1. 20 winners will receive a HK\$10,000 scholarship to subsidy his/her proposed training programme/ life planning, and a certificate. Each winner is required to submit a written report to the Secretariat by a certain date.
- 2. 10 selected candidates will receive book voucher valued HK\$1,000 for encouragement.
- 3. All candidates will receive a certificate of commendation at the ceremony.

#### Points to Note

- 1. The organizer reserves the right to disqualify candidates or strip the award shall the information be found fraudulent.
